Highlights:

Construction of the Approach Tunnel requires about 30m deep excavation below existing ground level with dimensions of approximately 300m x 22m / 50m. This excavation serves as an access shaft for tunnel boring machine (TBM) retrieval for the C820 Contractor and subsequent construction of a cut and cover Approach Tunnel to the West Kowloon Terminus. The excavation and lateral support (ELS) comprises a multiple level of temporary steel and concrete struts and waling system to retain the ground during excavation and support the temporary diaphragm walls. The contractor for this project is Bachy Soletanche – Laing O’Rourke Joint Venture, and URS-Benaim is the Contractor’s designer. Support from URS-Benaim and Bachy Soletanche – Laing O’Rourke Joint Venture in arranging this site visit is gratefully acknowledged.
