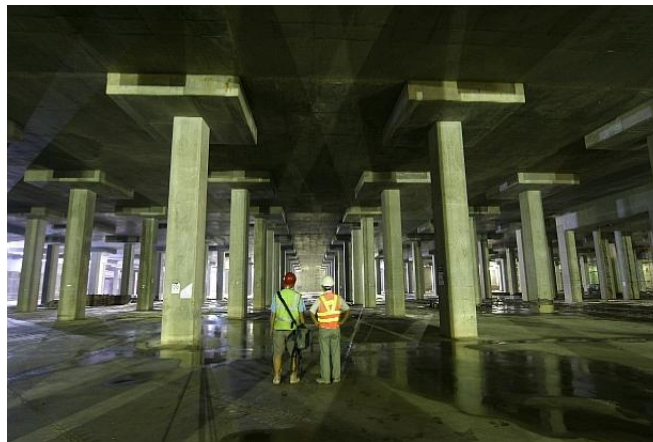


Technical Visit to Tai Hang Tung Underground Flood Storage Tank

Date of Site Visit:	11 February 2012 (Saturday)

Highlights:

The Tai hang Tung Underground Flood Storage Tank forms a key part of the Tai Hang Tung Storage Scheme (THTSS) by Drainage Services Department. This flood storage tank was constructed underneath the existing football and rugby fields. With a capacity of about 100,000 m³ (136mx130mx9.5m deep), it is the first large-scale underground flood storage tank in Hong Kong for alleviating flood issue of the MongKok District. It is designed to capture the peak flow and delay its discharge until the amount of storm water downstream had been reduced. ***The project has won the HKIE's innovation Award in 2002 and was completed in year 2004.***
